Trust has two Permanent Account Number (PAN). Letter for cancellation of PAN is given by the trust to the IT department and it is pending at IT department. TDS was deducted by bank of maharashtra on incorrect PAN number, therefore, TDS by bank of Maharshtra is not accounted for. However, trust has shown fixed deposits in books of accounts correctly.

It is suggested that specific rules to be framed for entire working / administration of the trust concern with eligibility, Retirement of the trustees, tenure of trustees, acceptance of resignations, policy regarding capital expenditure etc. Constitution with suggested changes is already submitted to Charity Commissioner, Pune & is pending with them for final approval (Under scheme no 28/15)

pending with them for final approval (Under scheme no.28/15). We obeserved that Income Tax Return were not filed by Trust (FY 2008-09, 2009-10, 2010-11, 2012-13, 2013-14, 2014-15). TDS for these years is appearing in Balance Sheet as Asset. It is not likely to be received as refund and we suggest to write them off.
