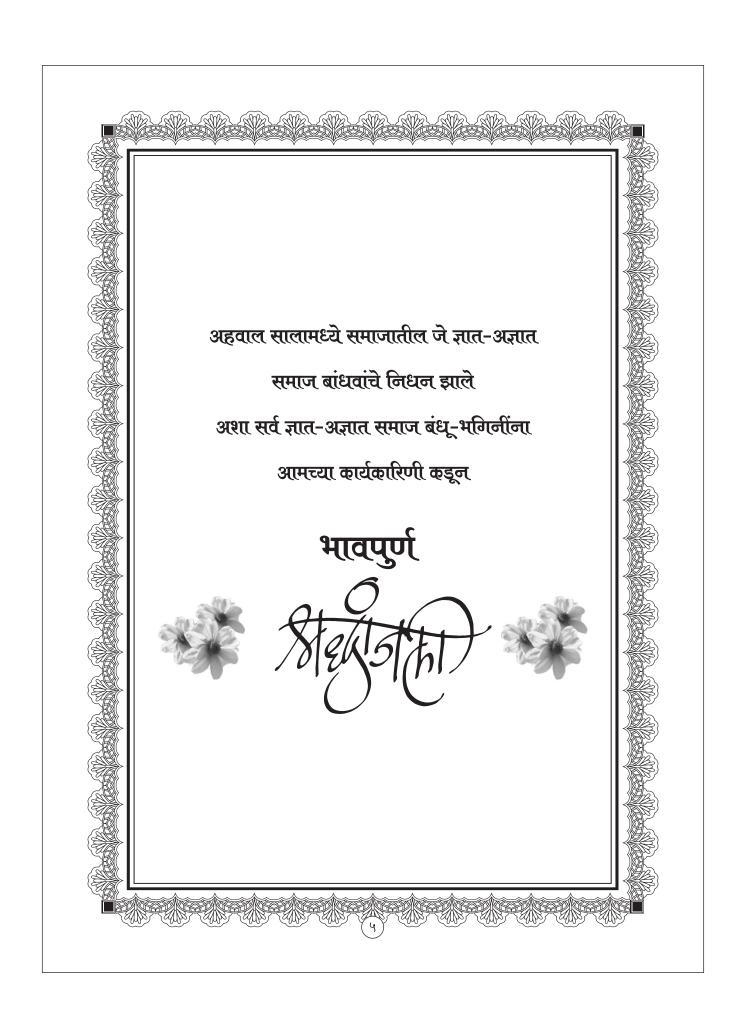

- Rs. 1792 is recoverable from old committee and we were told that letter for recovery is given to them.
- Contribution payable to charity commissioner has not been provided though it is payable now.
- We observed that Income Tax Returns were not filed by Trust (FY 2008-09, 2009-10, 2010-11, 2012-13, 2013-14, 2014-15). These Returns were time barred. TDS for these years is appearing in Balance Sheet as Asset. It is not likely to be received as refund and we Suggest to Write them off.
- FD with UCO Bank were physically not available with the trust. We were orally told that previous committee has not handover the physical copy of FD to the existing committee.
- No TDS has been made on professional fees paid to advocates.
- Trustees provided list of ornaments and informed that physical verification of same has been done by them.
- Provision for Tax out of Opening Balance is Rs. 7,89,776.71.
- Trust has Two Permanent Account Numbers (PAN). Letter for Cancellation of PAN is given by the trust to the IT Department and it is Pending.
- Constitution with Suggested changes is already submitted to Charity Commissioner, Pune & pending with them for Final Approval (Under Scheme no.28/15).
